MINUTES OF REGULAR MEETING  
JANUARY 19, 2010

The regular meeting of the Mackinaw Township Board was called to order at 6:00 P.M. on January 19, 2010 at 10595 Wallick Road, Mackinaw City, Michigan. Supervisor Dean led the Board in the Pledge of Allegiance.

Roll Call: Present: Dean, Keck, Bertchinger  
Absent: Davis, Rogala

Also present: Eric Jacobson

Agenda approved as presented. Minutes of November 17, 2009 approved on motion by Keck, second by Bertchinger. All aye, minutes accepted.

First item under unfinished business involved Assessor contract. It was agreed that Jacobson and Keck will meet with Rick Mahlmeister before the February meeting to review changes involved in adding assessor to payroll.

Keck reviewed the current status of the FEMA Floodplain maps and critiqued the information he had prepared for the Board Members. This Floodplain development will be very important to property owners in the future and it will be necessary for the Township to make sure they follow thru on any requirements. Attorney MacArthur arrived and gave his view on the importance of this plan.

MacArthur then brought the Board Members up to date on his appearance before the State Supreme Court. He also reported there has been a schedule set on the Crossings tax case. Two items the Board requested the attorney address in the future included new requirements involving Liquor Control and the question of sewer connections outside the village.

The response to the State concerning the 14 Point Review was discussed. The following motion was presented:
