## Reports

1. Lavender updated the Board on some of the changes to the new Assessing reform bill.
2. Smydra reported that the liquor license for the former Commodore has been transferred to the Hook restaurant so the Commodore would no longer need to be inspected. Falor will confirm this with the owner. There was discussion about the best way to address unexcused absences by a BOR member. Smydra will administer the oath of office to all the BOR members before their March organizational meeting.

## Unfinished Business

1. Attorney MacArthur reviewed the Client privileged communication regarding the Michigan Section 218 Agreement with Social Security. Since the township is covered by a Section 218 agreement and since the township pension plan ordinance does contain an opt out clause, any Board member, when they first become eligible to participate, can choose to opt out by submitting a notice in writing. The question of whether the position would need to be placed on the excluded list of the adoption agreement, when the individual opts out, or whether a written opt out notice by the new official would be sufficient will be explored by Attorney MacArthur.
