 The proposal from Darrow Brothers Excavating regarding the new township entrance was discussed. The Township must acquire a driveway permit from M-Dot to determine an exact project cost. Motion by Brew,

Once the township has a selection of potential accountants, they would then like to conduct an interview process.
- 6. Motion by Darrow, supported by Falor to increase election inspector and deputy clerk wages to \$20 per hour. Roll call vote: Ayes: Smydra, Brew, Falor, Darrow, Closs. Nayes: None. Motion Carried.
- 7. The 2024/2025 Preliminary Budget Report was distributed and discussed in depth.
- 8. Motion by Falor, supported by Brew to adopt the 2024 Poverty Exemption Guideline Resolution as presented. Roll call vote: Ayes: Darrow, Falor, Brew, Closs, Smydra. Nays: None Motion carried.

Treasurers Report/Bills/Financial Report

- 1. The Treasurers report was accepted as presented. BOR approved 2 veteran exemptions. When Shepler's turned in their personal property statement to the assessor they significantly overstated their property value which resulted in having to send money back. Mackinaw City School owed the township \$10,000 and has since paid. These issues have appropriately been resolved.
