Township General Appropriations Act for Mackinaw Township for Budget Year 2009/10 was reviewed by members. Motion by Keck, second by Davis to approve Appropriations Act. Roll Call: Ayes: Bertchinger, Dean, Rogala, Keck, Davis Nay: None

Motion by Keck, second by Rogala to Resolution to Establish Supervisor Salary for coming year at \$6688. Roll Call: Ayes: Bertchinger, Davis, Dean, Keck, Rogala. Nay: None

Motion by Rogala, second by Bertchinger to approve Clerk Salary for coming year at 12,711. Roll Call: Ayes: Bertchinger, Keck, Dean, Davis, Rogala. Nay: None

Motion by Davis, second by Keck to approve Treasurer Salary for coming year at \$14,575. Roll Call Ayes: Dean, Keck, Bertchinger, Rogala, Davis. Nay: None

Motion by Dean, second by Bertchinger to set Salary for Trustees as \$87.14 per meeting. Roll Call: Ayes: Rogala, Davis, Keck, Bertchinger, Dean. Nay: None
