Attorney MacArthur reviewed current items to come before the Board. There is a bankruptcy filing for property owned by Cheboygan Memorial Hospital. Attorney MacArthur then reviewed current Arnold Line Tax Issue. The hearing is now scheduled for June 24th at 9:A.M. As of this date there has not been a Bankruptcy filing by Arnold Line.

Wallick Road repair next item to be discussed. It was felt that this should be completed in one year if possible. Motion by Brew, second by Keck to approve contract with Cheboygan County Road Commission in the amount of \$104,929 for paving of this road. Roll Call: Ayes: Ostwald, Keck, Welch-Williams, Falor, Brew. Nay: None A check for 2% of the total will be sent to the CCRC.

Keck reviewed for Board Members the Recreation Plan he filed with the County since last meeting. This plan needed to be done by the end of April. A copy of the plan was distributed to the members with request they review and add to agenda next month.

Clean/Up day is scheduled for June 15, 2013. It was suggested that next year it would be wise to have a shredder truck on hand.

Order for bank calendars for next year will remain at 5, with entries the same. Motion by Keck, second by Ostwald to support this. All aye.

Flag repair (rope is broken) needs to be addressed. Motion by Brew, second by Welch-Williams that Keck will contact Schwartz Company in Cheboygan to inquire about repair. All aye, motion approved.
