SEPTEMBER 16, 2014

The regular meeting of the Mackinaw Township Board was called to order by Supervisor Falor at 7:00 P.M. on September 16, 2014. Pledge of allegiance was recited. Roll Call: Present: Keck, Falor, Brew, Williams, Absent Ostwald. Also present: Lavender, James Conboy. Agenda approved after addition of Liquor Control under Reports and Resolution for Campbell under New Business.

Approval of July 15, 2014 minutes as presented.

Lavender reported on current assessor activities. It appears there are no tax tribunal issues being filed this year. Residential reviews are being conducted and there appear to be a great deal of changes. This review will continue.

A review of two parcels of property the Township purchased several year ago on tax sale was introduced. The DNR has expressed an interest in purchasing these two lots. Motion by Brew, second by Williams to request Supervisor Falor to negotiate with the DNR to sale of these lots not to be less than \$800.00 each. All aye, motion approved.

Jim Conboy was introduced to Board Members and he reviewed the history of Freedom as he has been told by area historians. Mr. Conboy discussed the two benches now on the trail between Cheboygan and Mackinaw. The bench being discussed would be placed on the trail where it intersects with Freedom Road. The possibility of a small overhang with also be helpful as it would provide shelter from the sun. There would also be some sort of signage identifying the Freedom area. This project will be studied further until the March meeting on motion by Brew, second by Keck. All aye, motion approved.

Lou Vassilakos arrived at 7:20 and discussed the upcoming Meeting on the 17th with the Village of Mackinaw concerning Fire Protection for the coming year. Falor will also attend this meeting and a report will be brought back to the Board Members.

Keck reported that he had met with Chief Wyman in Mackinaw City and they have agreed to conduct the Liquor Inspections in our township for the amount of 800.00 per year. The first three months reports have been turned in.

Approval of Selected Election Workers for November 4, 2014 Election approved on motion of Brew, second by Williams. All aye, motion approved. These workers are: Sandra Prior, Darlene Krueger, Sharon Slusser, Mary Alexander, Donna Falor, Cecilia Waskiewica and Loretta Martinek.
