- Motion by Brew, supported by Closs to table discussion of the Assessors proposed new salary until next month. Motion carried.
- Motion by Brew, supported by Falor and carried, to approve the following Budget Amendments:

Move: Governing Body Office Supply (101-101-726) minus 325.00  
Elections Conference and Workshops (101-191-960) plus 325.00
- The 2017-2018 Preliminary Budget was distributed and will be reviewed at next months meeting.
- After comparing workers compensation premiums, Brew made the motion, supported by Closs, to change the township workers compensation insurance provider to Burnham & Flower Insurance Agency.
