We are also in the middle of conducting land and sales analysis for setting the 2025 assessments. Preliminary results show assessed values will continue to increase in 2025 using a two-year study. We utilize the Pivot Point application for conducting property inspections. This application allows an efficient process for conducting and assigning property inspections.
- 3. Smydra and Brew attended the Cheboygan County Road Commission meeting regarding 2025 road projects. This year each township is will be given \$25,000 to put towards their road project if their project exceeds a certain amount. The Township would like to work on Stimpson Road. We will wait to hear back on our options and estimated costs of this potential project. The township would also like to make sure we specify the turning radius as one turns off US 23 onto Stimpson Road.
