- 2. Ostman the Cheboygan County Commissioner gave a report. Cheboygan County has subcontracted the Cheboygan Humane Society for many years and there has been some lack of management. The previous director retired and they are in dire need of a new one. Jeff Lawson recently toured the humane society and they will be attending the next commissioner meeting to give an update on how the humane society operations are going. The Cheboygan County Building is getting a new generator that can operate the entire building during power outages. Mill Creek Campground submitted a permit to install a new office. This should help with traffic on US 23 Hwy.
- 3. Smydra and the Board of Review attended a required training class in Gaylord on February 13th. The state law now requires Board of Review Members to attend basic training every two years. Smydra attended an MTA meeting on January 30TH. The new sheriff was present and assured the townships he will continue enforcing the blight ordinance. Cheboygan County Road Commissioner Bradley Ormsbee has advocated for a millage increase specifically dedicated for road improvement. Mackinaw Township currently has a half millage rate contributing \$45,000 annually and receives \$25,000 back.
