## Reports

Attorney Timothy MacArthur presented the board with the final copy of the earned sick time policy and discussed in depth. Motion by Brew, supported by Smydra to adopt the Mackinaw Township assessor job description & policy for scheduling hours. Roll call vote: Ayes: Darrow, Brew, Closs, Smydra, Falor. Nays: None. Motion carried. Motion by Brew, supported by Smydra to adopt Mackinaw Township's sick time policy. Roll call vote: Ayes: Brew, Closs, Smydra, Darrow, Falor. Nays: None. Motion carried.

Supervisor Smydra reported to the board that the Stimpson Road project has been completed. The township board discussed road projects for 2026 in great depth and thoroughly looked over the new road ratings report for Mackinaw Township. Smydra has a meeting scheduled with the Cheboygan County Road Commission on November 5<sup>th</sup> to further discuss roads. He will request some price estimates on repairing Edgewater Beach Trail and a stretch of Old Mackinaw from Hebron Mail Route to Freedom Road. We hope to have these price estimates by our November meeting to further discuss. Smydra gave us an update on the discussion of short-term rentals such as Airbnb's. There has been multiple meeting to discuss this topic in great depth and parties from both sides have pleaded their case. At these meetings it has been clear that Cheboygan County has and will not have any authority in enforcing any policies for short term rentals. It is entirely up to each individual township to determine how they want to proceed with short term rental management. Smydra will be calibrating with Attorney MacArthur to create a policy for short terms rentals in Mackinaw Township. This topic will be further discussed at next months meeting.

Brew will create a proclamation for Mackinaw Township and present it to the board before the event.
